This change is being made for the Food Stamp Program to add the treatment of additional pay received by military personnel as a result of deployment to a combat zone.

On December 8, 2004, the President signed The Consolidated Appropriations Act, 2005, Public Law 108-447. This law contains a provision which excludes from consideration as income in the Food Stamp Program additional pay received by military personnel as a result of deployment to a combat zone.

Section 9.1,A,2,o contains the current policy regarding AG members expected to be absent from the AG for more than a calendar month.

Any portion of a payment received under Chapter 5 of Title 37, United States Code, by a member of the United States Armed forces deployed to a designated combat zone is excluded from household income for the duration of the member's deployment, when the additional pay is the result of deployment to or service in a combat zone, and the payment was not received immediately prior to serving in the combat zone.

Regardless of the arrangement made by the deployed soldier for his or her military pay, only that portion of the pay to which the applicant or participating Food Stamp household has access is counted when determining the AG's income for Food Stamp purposes.

Information regarding documentation of the deployed person's income and location has been added to Chapter 4. Attachment 1 of this DW-17 is a list of designated combat zones. Attachment 2 is a list of Chapter 5 of Title 37 pay items which may or may not be the result of deployment to a designated combat zone. These lists are attached for your convenience and will not be maintained in the Manual. These lists can be found www.fns.usda.gov/fsp/government/certification_policy.htm

Section 10.4,D,18 has been added to provide the steps necessary to determine the amount of income to count for the AG when funds are provided by military service personnel while serving in a designated combat zone. These steps apply to applicant households as well as recipients.

Due to the legislative requirement, this policy is retroactive to October 1, 2004. Any FS AG that had an increase in income, as a result of the deployment of the service member to a designated combat zone, that was counted in their Food Stamp income calculation as of October 1, 2004, is entitled to restoration of lost benefits. See Section 2.2,E. Workers must make such a determination at the AG's next determination, unless the AG requests a review of its case prior to that time. A household that was denied because excludable income was counted is also entitled to restoration of lost benefits. Any income excluded under this policy remains excluded until the AG's next redetermination.
