This change is being made to update references to Food Stamps, QI-2 and clarify the procedure for determining the equity of recreational vehicles and equipment and correct the procedure for coding recreational vehicles and equipment in RAPIDS in Chapter 11.

In order to be consistent, most references to FMV have been changed to CMV. See Section 11.1 for the definition of these terms.

This change also introduces a new form for verifying the value of recreational vehicles and equipment, the DFA-RV-1, which may be used for that purpose only.

Changes have also been made to remove a reference to adjusting Food Stamp certification periods in Chapter 10.
