This change was made to add and/or correct the following chapters:

**CHAPTER 12**

Section 12.10,B,5: Policy was added for consistency with Section 12.3,A.

Section 12.10,C: This section was added to clarify recently implemented procedures regarding the transfer of cases between counties with a pending MRT referral.

Section 12.15, A: The Food Stamp medical deduction was added to the provisions that require a determination of physical and/or mental disability.

Section 12.15,B: Policy was added to define disabled for the Food Stamp Program.

Appendices: A change was made to clarify a presumptive approval issue for HIV and AIDS.

**CHAPTER 15**

Section 15.3,H,2: Policy was included to address when a person who was penalized for non-cooperation with BCSE is eligible for AFDC Medicaid or AFDC-Related Medicaid.

## **CHAPTER 16**

References to budget group were changed to AG.

### Section 16.1,A:

Terminology regarding the Special Pharmacy Program was made consistent.

A statement was added to clarify insufficient income for immunosuppressant medication.

Clarification was added that names and costs of medications requested on the Special Pharmacy memorandum apply to immunosuppressant drugs only.

Policy was updated to reflect current information regarding Medicare's immunosuppressant drug coverage. Procedures were added concerning required action prior to the termination of Special Pharmacy coverage.

A formatting change was made.

### Section 16.1,B:

Income limits for this program were updated from 100% SON to at or below 100% of the FPL.

Policy was added to explain how lab costs related to Clozapine/Clozoril are used to determine eligibility for the Special Pharmacy Program. Procedures were added concerning required actions prior to termination of this coverage.

Section 16.1,E: Policy was changed to be consistent with Section 15.3,H,2.

Section 16.1,E,5: Minor formatting changes were made to the chart in this Section.

Section 16.5,A: Detailed information about the former AFDC cash assistance was removed. Minor formatting changes were made for consistency with the rest of the manual.

Section 16,5,B: A NOTE was added regarding BCSE cooperation for Extended Medicaid recipients.

Section 16.5,C: Policy was updated regarding PRL forms.

Section 16.5,D: The Qualified Children chart was deleted.

Section 16.5,E,2: Policy was updated.

Section 16.5,E,3: Policy to clarify postpartum issues was added.

Section 16.5,H: The Poverty-Level Children chart was deleted.

Section 16.5,I: Policy has been added to address CEN eligibility for children born to women eligible and receiving Medicaid from another state at the time of the birth and to address CEN children who leave West Virginia.

Section 16.6,A: Policy was added regarding SSI termination and eligibility for SSI-Related Medicaid.

Section 16.6,C,2: The name of a form was corrected.

Appendix A: Corrections were made to comply with TM Policy. A third page was added to the Appendix to detail the RAPIDS TM Process.

21.2,A,5, 21.2,B and Appendix A:

Policy was added to address replacement of Food Stamp benefits when the EBT card is stolen and benefits are accessed prior to receipt.

## **CHAPTER 23**

Section 23.1: The number of a Senate Bill was corrected.

Section 23.2: The name of the contractor tracking M-WIN premium payments was changed.
