#### 3.2 STATE DATA EXCHANGES

## A. BUREAU OF EMPLOYMENT PROGRAMS (BEP)

Wage information is obtained at application and quarterly thereafter. **Unemployment Compensation income** information is obtained monthly.

## **1.** Wage Information

Wage information is available around the 5<sup>th</sup> working day of each quarter for the previous quarter. Information received includes employer name and address, dates of employment, and wages for individuals whose actual earnings are \$225 or greater per quarter than the income used for the AG for the same quarter.

This information is not considered verified upon receipt for the Food Stamp Program and is subject to independent verification for all programs.

The RAPIDS data exchange type is BPSW and detail information is available on DXDW. A RAPIDS broadcast message is displayed when this data exchange occurs.

## 2. Unemployment Compensation Income (UCI)

UCI information is available around the 3<sup>rd</sup> working day of each month. Information received includes unemployment and low earnings benefits.

This information is considered verified upon receipt for the Food Stamp Program and is not subject to independent verification for any program.

The RAPIDS data exchange type is BPUC and detail information is available on DXDU. A RAPIDS broadcast message is displayed when this data exchange occurs.

### B. DIVISION OF CHILDREN AND ADULT SERVICES

Information from the Family and Children's Tracking System (FACTS) is provided monthly.

### 1. Provider Income

Provider Income information is available the 1<sup>st</sup> working day after the 2<sup>nd</sup> Friday of each month. Information received includes

adoption, foster care, day care, and demand payments for the previous month.

This information is not considered verified upon receipt for the Food Stamp Program and is subject to independent verification for all programs.

The RAPIDS data exchange type is FCTS and detail information is available on DXSS. A RAPIDS broadcast message is displayed when this data exchange occurs.

### 2. Client Detail

The adult and child information is available around the 10<sup>th</sup> calendar day of each month. Information received includes client income, asset, placement, demographic, and address details.

This information is not considered verified upon receipt for the Food Stamp Program and is subject to independent verification for all programs.

The RAPIDS data exchange type for adult details is FXAD and the FSCD for child details. Detail information is available on DXFA, DXFC, DXFP, and DXFD. A RAPIDS broadcast message is displayed when this data exchange occurs.

### C. WORKERS' COMPENSATION (WC)

Workers' Compensation information is available around the 5<sup>th</sup> calendar day of each month. Payment information received includes amount and date, coverage period, type of benefit, how payment was made, relationship of payee to claimant, and type of injury.

This information is considered verified upon receipt for the Food Stamp Program and is not subject to independent verification for any program.

The RAPIDS data exchange type is BPWC and detail information is available on DXWC and DXCR for the claimant payee. A RAPIDS broadcast message is displayed when this data exchange occurs.

# D. BUREAU FOR CHILD SUPPORT ENFORCEMENT (BCSE)

New Hire information is available each Monday. Information received includes names and addresses of employers, along with start and end dates of employment.

**BCSE** collects the New Hire information from employers. All employers do not report consistently when they do provide the information.

This information is not considered verified upon receipt for the Food Stamp Program and is subject to independent verification for all programs.

The RAPIDS data exchange type is CSNH and detail information is available on DXNH. An alert is sent to the Worker when a match occurs.
