Section 9.21: Reinstated permanent disqualification for parent or caretaker who fails to report child out of home.

Section 10.3: Added WV WORKS Employment Assistance Program payments as a source of income for other programs.

Section 13.10: Updated Age of Child good cause to apply to a single parent household only.

Section 15.6: Added benefits received from Separate State Funded programs to count towards lifetime limit.

Section 15.7: Added participation in a work activity as an eligibility requirement by 3 months of benefit receipt.
