The following changes were made:

CHAPTER 4

Sections 4.2,A,15 and 4.2,B,3: Verification procedures for Indian Lands and Trust Funds were added to each section.

CHAPTER 6

Section 6.3:

- All references to Food Stamps were changed to SNAP.
- All references to the ES-6 were updated to the DFA-6.
- A reference to the ES-10 was updated to the DFA-10.
- All references to the OFS-WVW-NL-1 were updated to the DFA-WVW-NL-1.

Section 6.3,C,2: An exception was added to the ES-NL-5 for the face-to-face requirement.

CHAPTER 9

Sections 9.4,B, 9.7,B, 9.8,B and 9.18,B: Ineligible / illegal aliens were added to the income group in each section.

CHAPTER 10

Section 10.7, D,8,e: Ineligible / illegal aliens were added.

CHAPTER 11

Section 11.1: A definition for land sale contract was added.

Section 11.2: Information regarding land contracts and acting as an authorized agent for an organization were added as inaccessible assets.

Section 11.4:

- A typo was corrected in the second example on page 23.

- Gift cards and gift certificates were added as assets.
- Information regarding Indian Lands and Trust Funds was moved to Appendix C.
- Land Contract was added as an asset.

Section 11.5: Property sold with a land contract was added.

Sections 11.6,C,1 and 11.6,C,2,a: Ineligible / illegal aliens were added.

Section 11.7,C,3,f: Undue Hardship for WV WORKS was deleted.

Appendix C was created for information regarding Indian Lands and Trust Funds that are excluded from income and assets.

CHAPTER 12

Section 12.8: All references to the DFA-7 were changed to the DFA-PHI-1.
