The following changes were made:

#### **CHAPTER 4**

Section 4.2,A,16: Verification requirements for promissory notes and determining the principal balance amount were added.

#### **CHAPTER 10**

Section 10.3, EE: Census 2010 pay was added as an employment income source.

Section 10.3, items ZZ and XXX: Corrections were made to the Medicaid income policy for loans and sale of property payments. Promissory notes and payments were added as new item HHH and all following items were relettered.

Appendix E: A column heading for Appendix E, PAC Method 1, was corrected.

#### **CHAPTER 11**

Section 11.1: The definition of burial spaces was clarified and definitions for creditor, negotiable agreements and promissory notes were added.

Section 11.4,II : Promissory notes were added as an asset. This policy applies to promissory notes negotiated on or after 11/1/09.

Section 11.4, items X and AA,4: Policy was added about land sale contracts and loans as an asset for the creditor, beginning with the contracts and loans negotiated on or after 11/1/09.

Section 11.4, KK,1: The designations for WVW, AFDC Groups and SSI Groups were changed to clarify the policy.

#### **CHAPTER 16**

Section 16.5,I: The requirement that a child born to a Medicaid-eligible woman resides continuously in the mother's household to qualify for CEN coverage was removed. This is no longer a requirement for the child to receive CEN coverage. The effective date for this policy is April 1, 2009, as part of the CHIP Reauthorization Act of 2009 (CHIPRA). Coverage must be reinstated for any individuals denied CEN coverage because they did not meet this requirement beginning April 1, 2009 until the effective date of this change.

Section 16.6, C: The e-mail address of the Medicare Buy-In Unit was corrected.

Section 16.6,D: A NOTE was added about enrollment in Medicare, Part A, for individuals enrolled in Part B with the Medicare suffix M. The e-mail address of the Medicare Buy-In Unit was corrected.

Section 16.7,H: New item headings were added in the section and Data System Coding and Communications with the Breast and Cervical Cancer Program (BCCSP) was added to include instructions which were previously released by e-mail.
