This change was made to update policy regarding income deposited into a joint account for the use of a non-AG member is not to be counted for WV WORKS. The Legal Aid Directory was updated. Two-parent families with an individual declared disabled by MRT must participate the required hours for a two-parent family. The scheduled hours in eRAPIDS must not exceed the minimum participation rate requirements.

SECTION 6, App A: Legal Aid Directory was updated.

SECTION 9.21, 10.6, 13.9, and 13.11: References to Food Stamp benefits were changed to SNAP.

SECTION 10.3: Clarified that income deposited into a joint account for the use of a non-AG member is not to be counted for WV WORKS.

SECTION 10.24: Clarified that no deductions or disregards are applied to the child support excess payment.

SECTION 24.3, 24.9, and 24.10: Clarified that the scheduled hours in eRAPIDS must not exceed the minimum participation rate requirement.

SECTION 24.3: Clarified that two-parent families with an individual declared disabled by MRT must participate the required hours for a two-parent family.
