This change was made to add AFDC Medicaid policy to Chapter 2, The Case Maintenance Process. In addition, technical changes, such as spelling corrections and the addition missing words, were made and clarifications were added to Chapter 2 and Chapter 16.

CHAPTER 2

Section 2.1,A: A clarification was added about a representative and technical corrections were made.

Section 2.1,B,1: Technical corrections were made. A reference to vendor payment status was removed since payments are no longer made to recipients in this manner.

Section 2.1,B,2,b: Information about the use of SOLQ for SSI Medicaid recipients was added.

Section 2.1,D: A technical correction was made.

Section 2.4: Technical corrections were made.

Section 2.4,D,3: A NOTE was added about when to begin Medicaid coverage when an individual cooperates with BCSE after a penalty is imposed. Clarification was added about the need for an application when an AG reports the birth of a child or a child moves into the home. Technical corrections were made

Section 2.4,D,4: Clarifying information was added about the need to evaluate an individual for other Medicaid coverage and for WV CHIP when Medicaid is closed. Information was added about AGs which have met spenddown and lose eligibility for reasons other than an income change or a decrease in the Needs Group.

Section 2.4,E,1: Overpayment of a nursing home contribution, due to Worker error, was added as a reason to reimburse an individual for out-of-pocket expenses.

Section 2.5: AFDC Medicaid case maintenance policy was added in this section. References to Section 2.3 were changed to Section 2.5.

Section 2.6,A: A NOTE was added about the eligibility of a child for Extended Medicaid AG when the child loses Medicaid eligibility in another coverage group.

Section 2.7: A NOTE was added about the eligibility of a child for Transitional Medicaid (TM) when the child loses Medicaid eligibility in another coverage group.

Section 2.8 A: A NOTE was added about the eligibility of a child for Transitional Medicaid (TM) or Extended Medicaid when the child loses Medicaid eligibility in another coverage group. Incarceration or institutionalization were added as reasons to close an AG during the CME period.

Section 2.8,C: A clarifying NOTE and EXAMPLE were added about children who move from one home to another in West Virginia during the CME period.

Section 2.16,B: A reference to Section 2.3 was changed to Section 2.5.

Section 2.16, D: Information was added about AGs which have met a spenddown and lose eligibility for reasons other than an income change or a decrease in the Needs Group.

CHAPTER 16

Section 16.5,C: A NOTE was added about the eligibility of a child for Transitional Medicaid (TM) or Extended Medicaid when the child loses Medicaid eligibility in another coverage group.

Section 16.7,F: A statement regarding resource development was added to the ADAP section.
