This change was made to remove time limits and requirements of ABAWDS. Participation with SNAP Employment and Training is voluntary. In the current Issuance Limited Counties (Cabell, Harrison, Kanawha, Marion, Raleigh, and Wood), a referral will be made to SNAP E&T but cooperating is voluntary. There will be no penalties for refusing to cooperate with SNAP E&T. There are no tracking of months that benefits are received. There will be no difference in the work requirements for SNAP participants not meeting an exemption. Participants are required to register with BEP unless exempt. Appendix B in Chapter 10 was updated to reflect new deduction amounts. The asset limit for AGs including a member who is elderly or disabled has increased to \$3250. This change includes 1, 2, 4, 6, 9, 10, 11, 13, and 25.
