<b>Tools/Equipment</b> \$1000/Lifetime	\$500 Lifetime
<b>Driver/chauffeur license</b> \$60 lifetime	\$50 lifetime
<b>CDL</b> \$200 Lifetime	\$100 lifetime
<b>Professional license</b> \$500 lifetime	\$300 Lifetime
<b>Relocation</b> \$2500 household lifetime	\$1500 household lifetime. Remove college, commuting time and payment for food and lodging. Added to EAP Add after receipt, ineligible for TANF for 3 months (except domestic violence)
<b>Transportation</b> \$450 month & mileage amount	\$225 month/\$50 week. Must meet weekly participation requirements. If full month participation requirements not met, evaluate for sanction. Prepayment limited to \$40.
<b>Vehicle Repair</b> \$2000 Lifetime	\$1500 lifetime. Removed additional EA payment of \$2000, added EA to regular lifetime limit
<b>Vehicle Insurance</b>	Removed additional EA payment of \$1000, added EA to regular lifetime limit
<b>DUI Offense</b> \$500 Lifetime	\$250 lifetime
<b>GED Bonus</b> \$500 Lifetime	\$100 Lifetime
<b>Self-Sufficiency Bonus</b> \$1500 lifetime	Remove 30 day, 90 day and 12 month amounts \$250 lifetime
<b>Vocational Bonus</b> \$500 Lifetime	\$250 Lifetime
<b>Emergency Assistance</b> \$5000 lifetime	Remove
