WV Birth to Three is aware that many of our practitioners attend Celebrating Connections to obtain contact hours for annual WV Birth to Three or licensure requirements. With the cancelling of Celebrating Connections this year, there are questions about where to go to find quality professional development on-line.

For our licensed practitioners, please reach out to your licensing board to verify which on-line professional development options are accepted within the state of West Virginia. There are many CEU offerings on-line but not all will be accepted by your licensing board. <u>Please note: WV Birth to Three follows the American Psychological Association guidance for contact hours- meaning you will get credit based on the time in training (for example, one hour of training equals one contact hour of professional development).</u>

WV Birth to Three has a variety of sessions offered via webinar and through self-paced on-demand courses. Many of these sessions have been updated and revised in the past year to stay current with emerging research and evidence- based practices. Extensions provide an additional 90 days to meet

enrollment requirements. Your annual enrollment date for the next year will remain the same. If you are due for annual enrollment on 4/1/2020, you will still be due for annual enrollment on 4/1/2021.
