Training Registration Process

You will have to register for all training sessions through the WVSTARS website – <https://wvregistry.org/ets/store/calendar/>. WV Birth to Three has a 2 step process for registering a Webinar. Once the information is visible on the right, please complete each of these:

The training includes an overview of family centered services, the IFSP process, procedural safeguards (family rights), required system components, personnel standards, and enrollment procedures. November 3, 2017 1:00 pm – 3:00 pm	Beginning the Partnership with Families (2 Contact Hours) Parents and other caregivers are the most important people in an infant and toddler's life. It is the responsibility of the early intervention provider/service coordinator to create a partnership with each family that is based on respect and focused on the identified needs of the family. Join us as we learn to become more family focused in our interactions by reflecting on our own values, beliefs and assumptions, utilizing strong active listening skills and recognizing the strengths that families bring to the partnership. Participants will also gain increased understanding of the purpose of an outcomes measurement system, and the purpose and use of the Child Outcome Summary Form (COSF) as it relates to measuring individual child progress and the WV Birth to Three System's ability to achieve broader systemic outcomes for individual children and families. How do children learn? How do they develop concepts that will be the foundations for all learning? What happens to this development if the child has a vision or hearing loss. This training will provide an overview of the distant senses: vision and hearing. Presentation will include the development of vision and hearing in "typical" children and the impact on child development, communication and social emotional development when there is an impairment in either or both sense(s). Participants will experience various sensory losses and discuss effective interventions and environmental adaptations that can be made to provide access to opportunities.	CGD	B

November 9, 2017 6:00 pm – 8:00 pm	Relationship Based Early Intervention Practices (2 Contact Hours) Current research recognizes that children's relationships with their parents and other consistent caregivers are critical to development. Relationship based practices in early intervention are intended to support the parent-child relationship and maximize the learning opportunities therein. This focus requires a change in the roles of professionals, requiring more than competence in one's discipline. This session will explore the components of relationship based practices, including perspectives on parent-child, parent-practitioner, and practitioner-practitioner relationships, and the skills needed for success in implementation. November 13, 2017 9:00 am – 11:00 am	Child Abuse Prevention and Treatment Act (CAPTA) (2 Contact Hours) Research over the past ten years has helped professionals in the field of early childhood begin to broaden our understanding of the influence of genetics and the environment on the development of young children. Because of this research, Congress, in 2003, enacted legislation to establish formal links between Part C early intervention programs and the state child welfare agencies through the Child Abuse Prevention and Treatment Act. This session will provide participants the latest research on the effects of: <ul style="list-style-type: none"> • child abuse, neglect and maternal substance abuse on the development of infants and toddlers; • current CPS policy for referring CAPTA families to WV Birth to Three; and, • effective practices for working with children/families engaged with the Child Welfare System.
