Training Registration Process

You will have to register for all training sessions through the WVSTARS website – <https://wvregistry.org/ets/store/calendar/>. WV Birth to Three has a 2 step process for registering a Webinar. Once you click on the training calendar search for the session you wish to attend, then click on the session to see additional details about the training on the right hand side of your screen. Once the information is visible on the right, please complete each of these:

This focus requires a change in the roles of professionals, requiring more than competence in one's discipline.
