

Behavior Consultant Corner, by Shannon Taylor

Do you have a child in your care who seems to be far more challenging than his peers? This is the child who has trouble staying on task, has frequent temper tantrums for seemingly "no reason," who ignores nearly everything that is asked of him, and who seems

to be falling behind in every developmental area: social-emotional, cognitive, motor, and especially language. Do you feel that you have exhausted every tried and true behavioral intervention with no success?

Before you chalk this child up as just another "trouble maker," take into considera-

tion that it is possible he may be dealing with a hearing loss on some level. If you have noticed that the child's behaviors tend to be worse when the room is loud or dark, this could be particularly indicative of a hearing deficiency. Additional noises in or around the room make it

difficult to focus on one person or task,

while a darkened room may inhibit the child's ability to determine the source and location of sounds, thus causing the child to act out as a result of fear.

If you suspect that a child has a hearing loss, document the reasons for your concerns (including behaviors observed and intervention techniques attempted) and approach his caregivers with the information. Take care to be sensitive to the caregivers'

reactions when discussing your concerns, and

encourage them to share the information you have provided with their pediatrician, as this is the only person who can officially diagnose a concern of this nature.

Here is a tidbit of valuable information you may want to pass along to your co-teachers and parents:

Over-the-Counter (OTC) Benzocaine Gels and Liquids

The FDA reports a rare, but serious and potentially fatal adverse effect with the use of OTC benzocaine gels and liquids applied to the gums or mouth. These are sold under different brand names such as Anbesol, Orajel, Baby Orajel and other store brands. The condition results in the amount of oxygen carried through the blood stream being greatly reduced.

The cases occurred mainly in children aged two years or younger who were treated with the gel for teething. The American Academy of Pediatrics recommends the following for treating teething pain: Benzocaine products should not be used on children less than two years of age, except under the advice and supervision of a healthcare professional. Give the child a teething ring chilled in the refrigerator. Gently rub or massage the child's gums with your finger to relieve the symptoms. Talk to healthcare professional to identify other treatments.

The WV EFCCS consists of 7 modules and a pre and post site visit of your program, using the Family Child Care Environmental Rating Scale (FCCERS).

The trainer will also be available to answer questions relating to the module series and on how to implement the Creative Curriculum into your Family Child Care program.

Upon completion of all 7 modules and both technical assistance visits you will be eligible for resource money to spend on improving and meeting the needs of your program. Also, you should be registered on the STARS Career Pathway to participate in the series. You may become registered by successfully completing a STARS application. 

Advocating Play

*If you want to get across an idea, wrap it up in a person.
-Ralph Bunche*

"The early childhood community, which has traditionally valued play as a learning tool, has not been very articulate about play's importance in our evidence-based school economy." This challenge was laid down by Elizabeth Graue, in her article, "Are We Paving the Paradise: In our rush to promote achievement, we've forgotten how 5 year olds really learn," in [Education Leadership](#) (April 2011). Graue further observes...

"The growing allocation of kindergarten time to academic content has firmly pushed play to the edges. What counts as play in many classrooms are highly controlled centers that focus on particular content labeled as 'choice' but that are really directed at capturing a specific content-based learning experience, such as number bingo or retelling a story exactly as the teacher told it on a flannel board....It means that in-depth project work that involves research into child-initiated questions just takes too much time...."

"What's lost with this shift? Attention to anything but clearly defined cognitive aspects of development...."

"...It's no longer enough to argue that play is the work of children; we're now required to prove what children get from play. What they get must translate to increased achievement or reduced risk. So let's nail the evidence base."



T.R.A.I.L.S. Corner

Let's talk about literacy! With sunny, warm days approaching, children and providers are drawn to the outdoors. We begin to focus on activities that can be carried out onto the playground. This spring and summer we would like to remind you about our large selection of literacy materials for all ages. These materials include books appropriate for infants through school-agers, bag books which include a book with props to help bring the story to life, books on tape, and big books for large group sharing. To support children's literacy, TRAILS has a number of teacher resource books on literacy and those with ideas to go beyond just the telling of the story. It is quick and easy to use children's books as a jumping off point for other great activities and ideas. Instead of gathering in the usual circle time area, grab a book and a blanket and head out-

doors. The children will love the change of pace and scenery after being inside all

winter long. There is nothing wrong with moving your typical classroom activities outdoors on warm, sunny days. Studies have shown children learn more and retain

more information when they have natural lighting and fresh air. So use TRAILS as not only a great place to get toys, but also

as another bookmobile. (We hope to see you all soon with the nice weather). Please do not hesitate to call with questions or material requests. Also, we always welcome new providers to join us in the TRAILS program.

Preventing Sun Exposure in Children

The best way to prevent sunburn is to avoid sun exposure. When working with young children who thrive on going outside, that advice is often impossible but there are many things you can do to

minimize a child's sun exposure:

Keep babies younger than 6 months of age out of the sun. If sunscreen is needed, a small amount on the face or back of hands is not harmful.

Teach the children the ABCs of how to prevent their skin from getting sunburned.

A = Away . Stay away from the sun in the middle of the day (from 10:00 am – 4:00pm)

B = Block. Use a sunscreen with a sun protection factor (SPF) of 15 or higher to protect babies and children's very sensitive skin.

C – Cover up. Wear clothing that covers the skin, hats with wide brims and sunglasses with UV protection. Even children 1 year old should wear sunglasses with UV protection.


S = Speak out. Teach others to protect their skin from sun damage.
