

Attached is a copy of the findings of fact and conclusions of law on your administrative disqualification hearing held April 26, 2005.

In arriving at a decision, the State Hearing Officer is governed by the Public Welfare Laws of West Virginia and the rules and regulations established by the Department of Health and Human Resources. These same laws and regulations are used in all cases to assure that all persons are treated alike.

For the purpose of determining, through an administrative disqualification hearing, whether or not a person has committed an intentional program violation, the following criteria will be used: Intentional program violation shall consist of having (1) made a false or misleading statement or misrepresented, concealed or withheld facts or (2) committed any act that constitutes a violation of the Food Stamp Act, the Food Stamp regulations, or any statute relating to the use, presentation, transfer, acquisition, receipt, or possession of Food Stamp coupons. (Section B. Appendix A, Chapter 700 of Common Chapters Manual) Individuals found to have committed an intentional program violation shall be ineligible to participate in the Food Stamp Program for a fixed period of time as explained in section 20.2(D)(2)(e) of the WV Income Maintenance Manual and 7 CFR Section 273.16.

The information submitted at the hearing revealed that you committed an intentional program violation of the Food Stamp Program by failing to report employment and earned income from TMK Enterprise Security Services, Inc. causing an overissuance of Food Stamps in the amount of \$1914 for the period of April, 2004 through November, 2004.

It is the ruling of the State Hearing Officer that you committed an Intentional Program Violation of the Food Stamp Program and you will be individually disqualified from participation in the Food Stamp Program for a period of one (1) year beginning June, 2005.

SUMMARY AND DECISION OF THE STATE HEARING OFFICER

I. INTRODUCTION

This is a report of the State Hearing Officer resulting from an administrative disqualification hearing concluded on April 26, 2005 for

This hearing was held in accordance with the provisions found in the Common Chapters Manual, Chapter 700 of the West Virginia Department of Health and Human Resources. This hearing was originally convened on April 27, 2005. It should be noted that the defendant did not attend the hearing but the hearing was convened in her absence as an appointment letter was sent by certified mail on March 11, 2005 notifying her of the date, time and location of the hearing and she signed a return receipt on March 12, 2005 acknowledging her receipt of the appointment letter.

All persons giving testimony were placed under oath.

II. PROGRAM PURPOSE

The Food Stamp Program is set up cooperatively between the Federal and State Government and administered by the West Virginia Department of Health and Human Resources.

The purpose of the Food Stamp Program is to provide an effective means of utilizing the nation's abundance of food "to safeguard the health and well-being of the nation's population and raise levels of nutrition among low-income households". This is accomplished through the issuance of food coupons to households who meet the eligibility criteria established by the Food and Nutrition Service of the U.S. Department of Agriculture.

III. PARTICIPANTS

1. Brian Shreve, Repayment Investigator.

Presiding at the hearing was Thomas M. Smith, State Hearing Officer and a member of the State Board of Review.

V.QUESTION(S) TO BE DECIDED

The question to be decided is whether it was shown by clear and convincing evidence that the defendant, committed an intentional program violation of the Food Stamp Program.

VII. FINDINGS OF FACT

- 1. Defendant was an active recipient of Food Stamps when she began employment at TMK Enterprise Security Services, Inc. on 3-5-04 (Exhibits #B and #E).
- 2. The Defendant did not report her employment and earned income from TMK Enterprise Security Services, Inc. until questioned about it during a Food Stamp review on 11-1-04 when the employment showed up on an employee wage printout (Exhibits #D and #F).
- 3. Defendant signed application/review form on 11-20-03 (Exhibit #I) acknowledging her understanding of the rights and responsibilities, including timely reporting, and her understanding of the penalties for Intentional Program Violation of the Food Stamp Program.
- 4. Verification received from TMK Enterprise Security Services, Inc. (Exhibit #E) showed that the defendant was hired on 3-5-04 and received her first pay on 3-29-04.
- 5. Case comments dated 3-16-04 (Exhibit #G) showed that the defendant was in the local DHHR office on 3-16-04 requesting verification of her benefits for the housing authority and failed to report that she had been hired on 3-5-04.
- 6. Mr. Shreve testified that the defendant intentionally withheld or concealed information related to employment at TMK Enterprise Security Services, Inc. causing an overissuance in the amount of \$1914 for the period of April, 2004 through November, 2004 (Exhibit #C) and requested a one-year disqualification period be imposed due to Intentional Program Violation.
- 7. The evidence and testimony show that the defendant committed an Intentional Program Violation of the Food Stamp Program which caused an overissuance of \$1914 for the period of April, 2004 through November, 2004 (Exhibit #C) as she withheld or concealed information on 3-16-04 regarding her employment at TMK Enterprise Security Services, Inc.

CONCLUSIONS OF LAW

1. According to Common Chapters Manual, Chapter 700, Appendix A, Section B, an intentional program violation consists of having intentionally made a false statement, or misrepresented, concealed or withheld facts, or committed any act that constitutes a violation of the Food Stamp Act, the Food Stamp Program Regulations, or any statute relating to the use, presentation, transfer, acquisition, receipt or possession of food stamp coupons.

VIII. DECISION

Based on the evidence and testimony presented, I must rule that sufficient evidence was presented during the hearing to show that Ms. committed an Intentional Program Violation of the Food Stamp Program. Ms. will be disqualified from participation in the Food Stamp Program for a period of one (1) year beginning June, 2005.
