These same laws and regulations are used in all cases to assure that all persons are treated alike.

Eligibility for the Aged/Disabled Waiver Program is based on current policy and regulations. One of these regulations specifies that for the Aged/Disabled Waiver Program, the client's monthly gross non-excluded income must be equal to or less than 300% of the SSI payment. (West Virginia Income Maintenance Manual section 17.24.

#### DECISION OF STATE HEARING OFFICER

#### I. INTRODUCTION:

This is a report of the State Hearing Officer resulting from a fair hearing concluded on September 28, 2007 for This hearing was held in accordance with the provisions found in the Common Chapters Manual, Chapter 700 of the West Virginia Department of Health and Human Resources. This fair hearing was convened on September 28, 2007 on a timely appeal filed April 26, 2007. Note: This hearing was previously scheduled on June 28, 2007. Following the issuance of an abandonment letter, claimant's representative provided good cause for failure to appear and the hearing was rescheduled.

It should be noted here that the Claimant's benefits have been denied pending a hearing decision.

#### II. PROGRAM PURPOSE:

The program entitled Aged/Disabled Waiver is set up cooperatively between the Federal and State governments and administered by the West Virginia Department of Health & Human Resources.

Under Section 2176 of the Omnibus Budget Reconciliation Act of 1981, states were allowed to request a waiver from the Health Care Financing Administration (HCFA) so that they could use Medicaid (Title XIX) funds for home and community-based services. The program's target population is individuals who would otherwise be placed in an intermediate or skilled nursing facility (if not for the waiver services). Services offered under the Waiver Program will include: (1) chore, (2) homemaker and (3) case management services. West Virginia has been offering the Waiver Services Program since July, 1982 to those financially eligible individuals who have been determined to need ICF level care but who have chosen the Waiver Program services as opposed to being institutionalized.

The question(s) to be decided is whether the Agency was correct in its decision to deny the Claimant's application for the Aged/Disabled Waiver (HCB) Program.

#### VII. FINDINGS OF FACT:

- 1) An application for the Aged/Disabled Waiver Program was filed April 23, 2007 for the Claimant.
- 2) At the time of application Claimant's income was verified as follows:
  - \$ 610 Pension from (D2) \$1403 Social Security (D3)

\$2013 Total monthly income

- 3) West Virginia Income Maintenance Manual § 17.24 (D5) states:

  The client's monthly gross non-excluded income is compared to 300% of the maximum SSI payment for a single individual.
- 4) West Virginia Income Maintenance Manual §Appendix A of Chapter 10 (D5) shows that the maximum SSI amount for a single individual is \$623 per month.
- 5) 300% of \$623 equals \$1869 which would be the gross non-excluded income limit for the Claimant.
- Claimant's representative indicates that his mother has met the medical eligibility requirements for the Aged/Disabled Program Services. She suffers from several medical conditions which make her disabled. Claimant's representative indicates that he understands that his mother's income exceeds the maximum allowable levels but is requesting an exception or special consideration be given to her as he feels that by allowing her to participate in the Aged/Disabled Waiver Program rather than going to a nursing home, it would save the state money. Claimant's representative is willing to sign estate recovery forms giving the state the rights to his mother's home in exchange for approval for the Aged/Disabled Waiver Program.

#### VIII. CONCLUSIONS OF LAW:

- 1) Policy requires that individuals applying for the Aged/Disabled Waiver Program meet a financial eligibility requirement as well as a medical eligibility requirement.
- 2) As part of the financial eligibility requirement an applicant's gross non-excluded income cannot exceed 300% of the current SSI income level. (WV Income Maintenance Manual section 17.24)
- 3) Evidence and testimony are clear that Claimant's non-excluded gross monthly income exceeds 300% of the current SSI income level
- 4) A review of the regulations indicates that there are no exceptions/hardship provisions permitted for the income eligibility test.

#### IX. DECISION:

It is the decision of the State Hearing Officer to **uphold** the Agency's decision to deny the Claimant's application for the Aged/Disabled, Title XIX (HCB) Waiver Program.
