#### **DECISION OF STATE HEARING OFFICER**

### I. INTRODUCTION:

This is a report of the State Hearing Officer resulting from a fair hearing for ---- convened on December 18, 2012. This hearing was held in accordance with the provisions found in Chapter 700 of the West Virginia Department of Health and Human Resources' Common Chapters Manual. This fair hearing was convened on a timely appeal, filed October 11, 2012.

It should be noted here that the Claimant's benefits under the Aged and Disabled Waiver program continue at the previous level of determination pending a decision from the State Hearing Officer.

#### **II. PROGRAM PURPOSE:**

The Aged and Disabled Waiver program, hereinafter ADW, is defined as a long-term care alternative that provides services that enable an individual to remain at or return home rather than receiving nursing facility (NF) care. Specifically, ADW services include Homemaker, Case Management, Consumer-Directed Case Management, Medical Adult Day Care, Transportation, and RN Assessment and Review.

Presiding at the hearing was Eric L. Phillips, State Hearing Officer and a member of the Board of Review.

Each individual participated telephonically in the proceedings.

# **IV. QUESTION TO BE DECIDED:**

The question to be decided is whether the Department was correct in its proposal to reduce the Claimant's homemaker service hours provided through the Medicaid Aged and Disabled Waiver program.

# V. APPLICABLE POLICY:

Aged and Disabled Home and Community Based Waiver Policy Manual Chapter 501.5.1.1(a) and 501.5.1.1 (b)

# VII. FINDINGS OF FACT:

- 1) On September 19, 2012, the Claimant was medically assessed to determine her continued eligibility and to assign an appropriate Level of Care (LOC) for participation in the Aged and Disabled Waiver Services (ADW) program. Prior to the re-evaluation, the Claimant was assessed at a Level "C" LOC (Exhibit D-4) under the program guidelines.
- 2) Lee Ann Beihl, WVMI assessing nurse, completed the Pre-Admission Screening (PAS) (Exhibit D-2), as part of her medical evaluation of the Claimant. Ms. Beihl testified that the Claimant was awarded a total of 16 points which resulted in a Level "B" LOC determination.
- 3) On September 25, 2012, the Claimant was issued a Notice of Decision (Exhibit D-3), which documents the approval of her medical eligibility for the ADW program and the reduction of her homemaker service hours which cannot exceed 93 monthly hours.

- 4) Upon review of her findings, Ms. Beihl acknowledged that she incorrectly assessed the Claimant in the areas of angina at rest, angina at exertion and disorientation and conceded three additional points to the Claimant's LOC.
- Aged/Disabled Home and Community-Based Services Waiver Policy Manual 501.5.1.1(a) and
  (b) documents there are four levels of care for clients of ADW homemaker services. Points will be determined based on the following sections of the PAS:
  - #23 Medical Conditions/Symptoms- 1 point for each (can have total of 12 points)
  - #24 Decubitus- 1 point
  - #25 1 point for b., c., or d.
  - #26 Functional abilities
    - Level 1-0 points
      - Level 2-1 point for each item a. through i.
      - Level 3- 2 points for each item a. through m.; i. (walking) must be equal to or greater than Level 3 before points are given for j. (wheeling)

Level 4 - 1 point for a., 1 point for e., 1 point for f., 2 points for g. through m.

- #27 Professional and Technical Care Needs- 1 point for continuous oxygen
- #28 Medication Administration- 1 point for b. or c.
- #34 Dementia- 1 point if Alzheimer's or other dementia
- #35 Prognosis- 1 point if terminal

The total number of points allowable is 44.

### LEVELS OF CARE SERVICE LIMITS

- Level A 5 points to 9 points- 0-62 range of hours per month
- Level B 10 points to 17 points-63-93 range of hours per month
- Level C 18 points to 25 points-94-124 range of hours per month
- Level D 26 points to 44 points- 125-155 range of hours per month

### VIII. CONCLUSIONS OF LAW:

- 1) Medicaid policy stipulates that an individual's LOC is determined by the number of points awarded on the PAS assessment tool.
- 2) On September 19, 2012, the Claimant was awarded a total of 16 LOC points as part of her PAS assessment, which resulted in a Level "B" LOC determination.

3) As a result of evidence and testimony presented during the hearing process, the Department conceded three additional points in the areas of angina at rest, angina at exertion and dementia; therefore, the total number of points assessed is 19. In accordance with existing policy, an individual with 19 points qualifies as a Level C determination and is eligible to receive a maximum of 124 homemaker service hours.

## IX. DECISION:

It is the decision of the State Hearing Officer to reverse the Department's proposal to reduce the Claimant's homemaker service hours under the Aged/Disabled, Title XIX (HCB) Waiver Services program.
