#### **DECISION OF STATE HEARING OFFICER**

#### **INTRODUCTION**

This is the decision of the State Hearing Officer resulting from a fair hearing for This hearing was held in accordance with the provisions found in Chapter 700 of the West Virginia Department of Health and Human Resources' (WV DHHR) Common Chapters Manual. This fair hearing was convened on September 10, 2015, on an appeal filed June 17, 2015.

The matter before the Hearing Officer arises from the June 9, 2015, decision by the Respondent to deny the Appellant's application for Long-Term Care (Nursing Home) Medicaid.

At the hearing, the Respondent appeared by Leane Soard, Economic Service Worker at the WV DHHR, County Office. The Appellant appeared *pro se*, represented by her daughter . All participants were sworn and the following documents were admitted into evidence.

After a review of the record, including testimony, exhibits, and stipulations admitted into evidence at the hearing, and after assessing the credibility of all witnesses and weighing the evidence in consideration of the same, the Hearing Officer sets forth the following Findings of Fact.

#### FINDINGS OF FACT

- 1) The Appellant submitted an application for Long-Term Care (Nursing Home) Medicaid (LTC-MA) on March 4, 2015.
- 2) As part of her application, she submitted verification of her liquid assets, three life insurance policies with cash values of \$1,439.96, \$101.01 and \$809.87 (Exhibit D-4) and a checking account with a balance of \$675.12 as of March 27, 2015 (Exhibit D-5). The total amount of the cash values of her life insurance policies was \$2,350.84, and the total amount of her liquid assets was \$3,025.96.
- 3) The Appellant assigned her life insurance policies to a funeral home in the WV, area, as part of a pre-need funeral arrangement. According to the assignment form (Exhibit D-6), the assignment is irrevocable. The assignment form was notarized on April 2, 2015.
- 4) The Department issued to the Appellant a letter of denial on June 9, 2015 (Exhibit D-2).

#### APPLICABLE POLICY

The West Virginia Income Maintenance Manual (WV IMM) Chapter 17, §17.10, states "The asset level for those eligible [for LTC-MA] by having income equal to or less than 300% of the monthly SSI payment for an individual is the same as for SSI-Related Medicaid."

WV IMM Chapter 11, §11.3, states that the asset level for SSI-Related Medicaid is \$2,000 for a single-person assistance group.

#### **DISCUSSION**

The Appellant was a resident of from March 4 through March 27, 2015. She applied for Long Term Care (Nursing Home) Medicaid on March 4, 2015.

She provided verification of the cash surrender values of her life insurance policies, and she provided verification that on April 2, 2015, she assigned these policies toward pre-need funeral costs. However, she still had access to these assets in March 2015.

The combined amount of liquid assets from the cash value of her life insurance policies and her checking account were \$3025.96 in March 2015, above the \$2,000 asset limit for LTC-MA.

# **CONCLUSION OF LAW**

At the time of her application for LTC-MA, the Appellant had \$3025.96 in liquid assets. The asset level for LTC-MA is \$2,000. Pursuant to WV IMM Chapter 11, §11.3, the Department acted correctly to deny the Appellant's application.

# **DECISION**

It is the decision of the State Hearing Officer to UPHOLD the Department's denial of the Appellant's application for LTC-MA.
