## **DECISION OF STATE HEARING OFFICER**

#### **INTRODUCTION**

This is the decision of the State Hearing Officer resulting from a fair hearing for **the state of the state o** 

The matter before the Hearing Officer arises from the April 27, 2015, decision by the Respondent to deny additional Person Centered Support-Agency Personal Options units for the Appellant under the I/DD Waiver program.

At the hearing, the Respondent appeared by **APS** Healthcare. The Appellant appeared by her sister, **APS** Healthcare. The Appellant were admitted into evidence.

After a review of the record, including testimony, exhibits, and stipulations admitted into evidence at the hearing, and after assessing the credibility of all witnesses and weighing the evidence in consideration of the same, the Hearing Officer sets forth the following Findings of Fact.

## FINDINGS OF FACT

- 1) A request (D-3) for 6,240 units of Person Centered Support-Personal Options (PCS-PO) under the I/DD Waiver program was submitted on behalf of the Appellant on April 22, 2015.
- 2) The Department issued a Notice on April 27, 2015, advising that of the 6,240 units of PCS-PO that were requested, only 2,900 units were approved.
- 3) The Appellant's individualized budget for service year May 2015-April 2016 is \$64,396.55. The approval of the total amount of PCS-PO units requested would cause the Appellant to exceed her budget by \$9,000.

## APPLICABLE POLICY

WV Medicaid Provider Manual §513.9.2.3.2 states that the amount of Person Centered Support services is limited by the member's individualized budget. The budget allocation may be adjusted only if changes have occurred regarding the member's assessed needs.

## **DISCUSSION**

The Appellant's representative contended that due to her full-time employment, there are several hours a day that the Person Centered Support services are utilized to ensure that the Appellant has constant supervision. The Appellant's representative argued that the 2,900 units that were approved will not cover the time between the Appellant's return from the day program she attends, and when the Appellant's representative returns home from work.

#### **CONCLUSIONS OF LAW**

The services under the I/DD Waiver program are limited to the individualized budget that is determined yearly by a member's functional assessment. The approval of the total amount of Person Centered Support-Personal Options units for the Appellant would cause her to exceed her allocated budget amount, and therefore only a portion of the services could be approved.

## **DECISION**

It is the decision of the State Hearing Officer to **uphold** the decision of the Department to deny the requested amount of Person Centered Support-Personal Options services under the I/DD Waiver program.
