#### **MEMBERSHIP UPDATE-**

## TAKE ME HOME WV UPDATE

Marcus Canaday gave us an update Demonstration Transition Program

- Ended 31 December 2018 thru Money Follows the Person (MFP)
- Transitioned 274 and carried over 3 people
- Over 220 People successfully completed 365 days in community
- 45-50 people are in that 365-day window

## Sustainability Initiatives

- Aged Disabled Waiver Program
- Online Case management- Up & Running March 2019
  - Working to resolve issues.
  - Will run approximately 1 year before making recommendations
- Telehealth Pilot
  - Completed design phase with WVU
  - Gave presentation
  - Will help transition people out of facility-based care
  - Remote monitoring, Fall Monitoring, Care Coordination
  - Budget runs calendar year, and is still pending with CMS
- No Wrong Door Plan
  - Prioritize Activities etc.
  - Requested funding to implement it
  - Priority and working with CED on this
- Person Centered Planning
  - Talking to CED about Centered Person Planning to evaluate policies etc.
  - Target Policymakers, advocates, people with disabilities to help CMS plan, for Centered Person Planning
- Money Follows the Person (MFP)
  - 3-month extension carried with it a 112 million dollars of funding to extend demonstration program
  - CMS verbally told us to submit a budget on how we would like to use MFP Funding
  - Requirements are the same
  - Will Collect rebalancing \$\$
- Waiver Program
  - o Implemented January 1, 2019
  - ADW had transition like 4 or 5

IDD Waiver- has 12 slots,

There was a question asked if there were any plans to extend the 12 IDD Waiver slots? The IDD Waiver program would need to identify the funding, and if there is a reauthorization, they could identify ICF's. There is a reauthorization (Companion bills) for a 5-year extension, we can reevaluate those 12 IDD waiver slots and see what is needed, what funding is needed to extend the program. If additional funding because available, then the state could look again. Original decision was made 2010.

Esther Hupp (housing coordinator) with MFP is targeting info about housing and the housing industry and developing information into a draft.

Ann McDaniel suggested we keep an eye on this and expression an opinion on the MFP and keeping watching the 12 IDD Slots and ICF.

Teresa M- Pat has been in the process of the CMS Audit.

Children with SED Waiver is out for public comment until May 22, 2019

Justice Reinvestment act has hired a housing coordinator-Annual costs jail & prison- \$25,879

Bill passed for ICFs- oversight committee-Person Centered Planning- Consumer Controlled,

Elliot Birckhead lets us know that Heather Holscher-Garcia from West Virginia Behavioral Health Planning Council's adult service committee brought to his attention some concerns about LogistiCare.

Use of telehealth could help with some access/ transportation issues Great discussion about Education and Olmstead-Great discussion about Jails/Prisons and Olmstead-

- Accessibility Checker in Word
- Accessibility Italics- Track change works well in highlight, might be easier for JAWS
- Update our membership list/possible consider having education, veteran's administration

### TRANSITION AND DIVERSION PROGRAM

- 120 Applications, 82 was approved, majority was lift chairs, ramps etc., 38 were denied because they did not meet the imminent risk,
- Spent \$111,118.09, and balance was \$81,831.91
