Attached is a copy of the findings of fact and conclusions of law on your hearing held November 3, 2005. Your hearing request was based on the Department of Health and Human Resources' action to deny your School Clothing Allowance application.

In arriving at a decision, the State Hearings Officer is governed by the Public Welfare Laws of West Virginia and the rules and regulations established by the Department of Health and Human Resources. These same laws and regulations are used in all cases to assure that all persons are treated alike.

Eligibility for the School Clothing Allowance Program is based on current policy and regulations. Some of these regulations state as follows:

Gross non-excluded income for the AG is totaled and compared to 100% FPL. There are no deductions from the gross non-excluded income, whether the income is earned or unearned. Income is prorated and converted as appropriate to arrive at a monthly amount as it is for any other program. If the gross non-excluded income is equal to or greater than 100% FPL, the family is ineligible for WVSCA. (West Virginia Income Maintenance Manual Chapter 15, Appendix C (I) Income - 2005 West Virginia SCHOOL CLOTHING ALLOWANCE (WVSCA).

The information submitted at your hearing revealed: You had excessive monthly income for the West Virginia School Clothing Allowance program.

It is the decision of the State Hearings Officer to uphold the action of the Department to deny the School application.

| | DECISION OF THE STATE HEARING OFFICER |
| I. | INTRODUCTION: |
| | This is a report of the State Hearing Officer resulting from a fair hearing concluded on November 15, 2005 for Ms This hearing was held in accordance with the provisions found in the Common Chapters Manual, Chapter 700 of the West Virginia Department of Health and Human Resources. This fair hearing was convened on November 3, 2005 on a timely appeal filed October 17, 2005. |
| | It should be noted here that Ms did not receive the 2005 School Clothing Allowance benefits. A pre-hearing conference was held between the parties prior to the scheduled hearing and, Ms did not have legal representation. Ms requested to have the hearing conducted by conference call. The hearing convened on November 3, 2005 rather than November 1, 2005 due to the scheduling notice being misplaced. |
| II. | PROGRAM PURPOSE: |
| | The Program entitled School Clothing Allowance is set up cooperatively between the Federal and State governments and administered by the West Virginia Department of Health & Human Resources. |

The WV WORKS School Clothing Allowance (SCA) Program is designed to provide clothing assistance for school age children. These children must be foster children or recipients of WV WORKS during the month of July. The West Virginia School Clothing Allowance (WVSCA) provides clothing assistance for school age children in families who do not wish to apply or are not financially eligible for WV WORKS but whose income is equal to or less than 100% of the Federal Poverty Level.

| VII. | FINDINGS OF FACT: |
| | 1) Ms applied for the School Clothing Allowance Program on July 13, 2005. She received monthly Social Security Benefits in the amount of \$1,034.00 and, intermittent Child Support Payments (Exhibit D-3). The Department averaged Ms's child support payments for April 2005 through June 2005 to determine a three (3) month average. The amount totaled \$454.00 ÷ 3 = \$151.00 + \$1,034.00 (Social Security) = \$1,185.00 Average Monthly Income. The income guidelines are based on the 100% Federal Poverty Level (FPL). Ms's income was based on a two member household with a FPL of \$1,070.00 (Exhibit D-2). Ms. Cassandra Toliver received a message from the Customer Service Center on August 15, 2005, regarding the clothing allowance. Ms. Toliver reviewed the case and determined the case |

was correct (Exhibit D-5). The Department denied Ms. ______'s School Clothing Allowance

application by letter dated August 16, 2005 (Exhibit D-1). The letter stated in part, "Your application for School Clothing Allowance dated 07/13/05 has been denied. Income is too much for you to receive benefits." Ms. ______ requested a Fair Hearing on October 17, 2005. The hearing finally convened on November 3, 2005.

2) To support the Department's action, Ms. Cassandra Toliver referred to West Virginia Income Maintenance Manual Chapter 15, Appendix C (I) Income - 2005 WEST VIRGINIA SCHOOL CLOTHING ALLOWANCE (WVSCA) states:

Gross non-excluded income for the AG is totaled and compared to 100% FPL. See Chapter 10, Appendix A. There are no deductions from the gross non-excluded income, whether the income is earned or unearned. Income sources are treated according to the WV WORKS column in Section 10.3. Income is prorated and converted as appropriate to arrive at a monthly amount as it is for any other program. See Section 10.24, A. If the gross non-excluded income is equal to or greater than 100% FPL, the family is ineligible for WVSCA.

NOTE: No deductions or disregards, including the \$50 child support deduction, are applied.

- 3) West Virginia Income Maintenance Manual Chapter 10, Appendix A INCOME LIMITS states in part, "The 100% Federal Poverty Level (FPL) for a two (2) person household is \$1,070.00."
- 4) West Virginia Income Maintenance Manual Chapter 15, Appendix B (A) 2005 WEST VIRGINIA SCHOOL CLOTHING ALLOWANCE (SCA) APPLICATION PROCESS states in part, "The application process is the same as for the WV WORKS applicants."
- 5) Ms. _____ did not dispute the Department's position.

VIII. CONCLUSIONS OF LAW:

West Virginia Income Maintenance Manual Chapter 15, Appendix C (I) Income - 2005 WEST VIRGINIA SCHOOL CLOTHING ALLOWANCE (WVSCA) states:

Gross non-excluded income for the AG is totaled and compared to 100% FPL. See Chapter 10, Appendix A. There are no deductions from the gross non-excluded income, whether the income is earned or unearned. Income sources are treated according to the WV WORKS column in Section 10.3. Income is prorated and converted as appropriate to arrive at a monthly amount as it is for any other program. See Section 10.24, A. If the gross non-excluded income is equal to or greater than 100% FPL, the family is ineligible for WVSCA.
