#### DECISION OF STATE HEARING OFFICER

#### **INTRODUCTION**

This is the decision of the State Hearing Officer resulting from a fair hearing for This hearing was held in accordance with the provisions found in Chapter 700 of the West Virginia Department of Health and Human Resources' (WV DHHR) Common Chapters Manual. This fair hearing was convened on September 21, 2016, on an appeal filed August 8, 2016.

The matter before the Hearing Officer arises from the August 3, 2016 decision by the Respondent to deny the Appellant's application for the 2016 School Clothing Allowance (SCA) program.

At the hearing, the Respondent appeared by Cathy Estep, Family Support Supervisor. The Appellant appeared *pro se*. The participants were sworn and the following documents were admitted into evidence.

After a review of the record, including testimony, exhibits, and stipulations admitted into evidence at the hearing, and after assessing the credibility of all witnesses and weighing the evidence in consideration of the same, the Hearing Officer sets forth the following Findings of Fact.

## FINDINGS OF FACT

- 1) The Appellant completed an application for the WV School Clothing Allowance (SCA) program (Exhibit D-1) on July 28, 2016.
- 2) The WV DHHR, County office, date-stamped the application (Exhibit D-1) as received on August 1, 2016.
- 3) The Department denied the Appellant's SCA application on August 3, 2016, because the program application period ended on July 31, 2016.

#### APPLICABLE POLICY

WV Income Maintenance Manual Chapter 15, Appendix C, Section 4 reads as follows:

The date of the application [for the School Clothing Allowance program] is the date that the DFA-2 or DFA-WVSC-1, which contains at least the applicant's name and address or the date the electronic signature is submitted in inROADS.

If the DFA-WVSC-1 is received by mail, the date of application is the date the form is received in the local office.

#### **DISCUSSION**

The Appellant mailed her application for the School Clothing Allowance (SCA) program (Exhibit D-1) to the Department on July 28, 2016. The Department did not receive it until August 1, 2016. Policy at IMM Chapter 15, Appendix C, Section 4, states that the date of application for the SCA program is the date the application form is received at the DHHR office.

The DHHR's inROADS on-line benefit application web site (Exhibit D-2) states that applications received after July 31, 2016, "must be denied."

The Department correctly denied the Appellant's July 28, 2016 SCA application.

# **CONCLUSION OF LAW**

The Department acted correctly to deny the Applicant's July 28, 2016 application for the School Clothing Allowance program, pursuant to IMM Chapter 15, Appendix C.
