Attached is a copy of the findings of fact and conclusions of law on your hearing held March 14, 2006. Your hearing request was based on the Department of Health and Human Resources' proposal to terminate your benefits and services under the Aged/Disabled (HCB) Title XIX Waiver Services Program.

In arriving at a decision, the State Hearing Officer is governed by the Public Welfare Laws of West Virginia and the rules and regulations established by the Department of Health and Human Resources. These same laws and regulations are used in all cases to assure that all persons are treated alike.

Eligibility for the Aged/Disabled Waiver Program is based on current policy and regulations. Some of these regulations state as follows: The Aged/Disabled (HCB) Title XIX Waiver Services Program is granted to those individuals who meet all eligibility requirements. One of these requirements is that the individual must qualify medically. Eligible individuals are those who qualify medically for a nursing facility level of care but have chosen the waiver program as a means to remain in their home where services can be provided. [Aged/Disabled (HCB) Services Manual Section 570]

Information submitted at your hearing revealed that you do not meet medical eligibility requirements for the Aged/Disabled Waiver Program.

It is the decision of the State Hearing Officer to **uphold** the proposal of the Department to terminate your benefits under the Aged/Disabled Waiver Program.

DECISION OF STATE HEARING OFFICER

I. INTRODUCTION:

This is a report of the State Hearing Officer resulting from a fair hearing concluded on April 4, 2006 for ______. This hearing was held in accordance with the provisions found in the Common Chapters Manual, Chapter 700 of the West Virginia Department of Health and Human Resources. This fair hearing was convened on March 14, 2006 on a timely appeal filed January 5, 2006.

II. PROGRAM PURPOSE:

The program entitled Aged/Disabled Waiver is set up cooperatively between the Federal and State governments and administered by the West Virginia Department of Health & Human Resources.

Under Section 2176 of the Omnibus Budget Reconciliation Act of 1981, states were allowed to request a waiver from the Health Care Financing Administration (HCFA) so that they could use Medicaid (Title XIX) funds for home and community-based services. The program's target population is individuals who would otherwise be placed in an intermediate or skilled nursing facility (if not for the waiver services). Services offered under the Waiver Program will include: (1) chore, (2) homemaker and (3) case management services. West Virginia has been offering the Waiver Services Program since July, 1982 to those financially eligible individuals who have been determined to need ICF level care but who have chosen the Waiver Program services as opposed to being institutionalized.

IV. QUESTIONS TO BE DECIDED:

The question(s) to be decided is whether the Agency is correct in its proposal to terminate services under the Aged/Disabled Waiver (HCB) Program.

VII. FINDINGS OF FACT:

- 1) The Claimant's Aged & Disabled Waiver case, hereinafter ADW, was undergoing a reevaluation to determine continued medical eligibility.
- 2) West Virginia Medical Institute completed a medical assessment (D-2) on November 23, 2005 and determined that the Claimant is not medically eligible to participate in the ADW Program.
- 3) The Claimant was notified of the potential denial (D-3) on December 2, 2005 and advised that she had two weeks to submit additional medical information. Additional information was provided on December 7, 2006 (D-3).
- 4) On December 23, 2005, a denial notice (D-4) was sent to the Claimant.
- 5) Ms. **Description** reviewed the PAS 2005 (D-2) and testified that three (3) deficits were established as a result of the assessment and the additional information submitted by the

Claimant. Those deficits were in the areas of physical assistance with bathing, dressing and transferring.

6) The Claimant's witnesses contended that additional deficits should be awarded in the following areas:

Eating- The Claimant testified that she has difficulty cutting and using her hands, but she does not eat meat so she does not have a need to cut it. She stated that she cannot chew because she has very few teeth and her diet consists of soft foods. She is able to eat the soft food with a fork or spoon.

Grooming and/or medication administration- The Claimant's husband applies the medicated lotion Olux to her skin as a result of exema and alopecia. Ms. responded that applying prescribed medication is not considered part of grooming and that the Claimant reported being able to complete other grooming activities. The Claimant testified that her homemaker applies regular, non-medicated lotion to her back as well.

Decubitis- The Claimant testified that her toes overlap as a result of arthritis, causing sores and bunions. Ms. **Example 1** testified that she observed a contracture, but that the sores would not classify as decubitis (pressure sores).

7) Aged/Disabled Home and Community-Based Services Manual Section 570 (D-1)-Program Eligibility for client:

Applicants for the ADW Program must meet the following criteria to be eligible for the Program:

- C. Be approved as medically eligible for NF Level of Care.
- 8) Aged/Disabled Home and Community-Based Services Manual Section 570.1.a Purpose: The purpose of the medical eligibility review is to ensure the following:
 - A. New applicants and existing clients are medically eligible based on current and accurate evaluations.
 - B. Each applicant/client determined to be medically eligible for A/DW services receives an appropriate LOC that reflects current/actual medical condition and short and long-term services needs.
 - C. The medical eligibility determination process is fair, equitable and consistently applied throughout the state.
- 9) Aged/Disabled Home and Community-Based Services Manual Section 570.1.b Medical Criteria:

An individual must have five deficits on the PAS to qualify medically for the A/DW Program. These deficits are derived from a combination of the following assessment elements on the PAS:

A. Decubitus - Stage 3 or 4 (Item 24 on PAS 2005)

B. Unable to vacate a building- a person is physically unable at all times at Level 3 or higher in walking or mentally incapable of leaving the building at Level 3 or higher in orientation with a diagnosis of dementia, Alzheimers, or related condition. (Item 25, I and 33, on the PAS 2005).

C. Functional abilities of individual in the home. (Item 25 on the PAS 2005).

Grooming	Level 2 or higher (physical assistance or more)

D. Individual has skilled needs in one or more of these areas B (g)suctioning, (h)tracheostomy, (i)ventilator, (k)parenteral fluids, (l)sterile dressings, or (m) irrigations. (Item 26 on the PAS 2005)

E. The individual is not capable of administering his/her own medications is defined as an individual not capable of administering his/her own medications if the prescription medication must be placed in the recipient's hand, mouth, tube or eye by someone other than the recipient at all times.

VIII. CONCLUSIONS OF LAW:

- 1) Policy clearly specifies that an individual must be awarded five (5) deficits on the PAS 2005 in order to qualify medically for the Aged/Disabled Waiver Program.
- 2) The Claimant received three (3) deficits on the PAS completed by Ms. in conjunction with her annual medical reevaluation.
- 3) As a result of testimony presented during the hearing, one (1) additional deficit is awarded for grooming. The Claimant testified that her homemaker physically assists her with grooming by applying body lotion to her back.
- 4) No additional deficit is awarded for medication administration. While Olux is unquestionably a prescribed medication applied by the Claimant's husband, the PAS 2005 stipulates that medication administration is specifically defined as medicine that

must be placed in the recipient's hand, mouth, tube or eye by another individual. The policy makes no reference to medication that is applied to the skin.

- 4) No additional deficit is awarded for decubitis as Ms. testified that the Claimant's toe sores are not classified as pressure ulcers.
- 5) The addition of one (1) deficit brings the Claimant's total number of deficits to four (4) and she continues to lack the five (5) required deficits for Aged/Disabled Waiver Program eligibility. Therefore, the Department's proposal to terminate Waiver services is valid.

IX. DECISION:

It is the decision of the State Hearing Officer to **uphold** the Agency's proposal to terminate the Claimant's benefits and services under the Aged/Disabled Title XIX (HCB) Waiver Program.
