Attached is a copy of the findings of fact and conclusions of law on your hearing held July 28, 2009. Your hearing request was based on the Department of Health and Human Resources' determination of homemaker hours under the Aged and Disabled Waiver Program.

In arriving at a decision, the State Hearing Officer is governed by the Public Welfare Laws of West Virginia and the rules and regulations established by the Department of Health and Human Resources. These same laws and regulations are used in all cases to assure that all persons are treated alike.

The Aged and Disabled Waiver (ADW) Program is based on current policy and regulations. One of these regulations specifies that for the ADW Program, the number of homemaker service hours is determined based on the Level of Care. The Level of Care is determined by evaluating the Pre-Admission Screening Form and assigning points to documented medical conditions that require nursing services. Program services are limited to a maximum number of units and hours, which is reviewed and approved by the West Virginia Medical Institute. (Chapter 501 – Covered Services, Limitations, and Exclusions for Aged and Disabled Waiver Services, §501.3.2.1; §501.3.2.2)

The information that was submitted at your hearing revealed that the Department was correct in its determination of your Level of Care and corresponding homemaker hours.

It is the decision of the State Hearing Officer to **uphold** the Department's determination of homemaker hours under the Aged and Disabled Waiver Program.

### **DECISION OF STATE HEARING OFFICER**

### I. INTRODUCTION:

This is a report of the State Hearing Officer resulting from a fair hearing concluded on August 28, 2009 for -----. This hearing was held in accordance with the provisions found in the Common Chapters Manual, Chapter 700 of the West Virginia Department of Health and Human Resources. This fair hearing was convened on July 28, 2009 on a timely appeal, filed February 13, 2009.

It should be noted that benefits have been continued by the Department.

All persons offering testimony were placed under oath.

### II. PROGRAM PURPOSE:

The ADW Program is defined as a long-term care alternative that provides services that enable an individual to remain at or return home rather than receiving nursing facility (NF) care. Specifically, ADW services include Homemaker, Case Management, Consumer-Directed Case Management, Medical Adult Day Care, Transportation, and RN Assessment and Review.

## IV. QUESTION TO BE DECIDED:

The question to be decided is whether the Department was correct in its determination of the Claimant's homemaker hours under the Aged and Disabled Waiver Program.

### VII. FINDINGS OF FACT:

- 1) Claimant is a 56-year old female recipient of Aged and Disabled Waiver (ADW) Services for whom a reevaluation was completed on December 1, 2008 (Exhibit D-2).
- 2) The Department issued a Notice of Decision (Exhibit D-3) to the Claimant on or about December 2, 2008. The notice states, in pertinent part:

You have been determined medically eligible to continue to receive in-home services under the Aged and Disabled Waiver Program. The number of homemaker service hours approved is based on your medical needs, and cannot exceed 93 hours per month. 3) Policy from Chapter 501 – Covered Services, Limitations, and Exclusions for Aged and Disabled Waiver Services, §501.3.2.1; §501.3.2.2 (Exhibit D-1), states, in pertinent part:

### 501.3.2.1 LEVELS OF CARE CRITERIA

There are four levels of care for homemaker services. Points will be determined as follows, based on the following sections of the PAS:

- 4) The West Virginia Medical Institute (WVMI) RN reviewed the Claimant's December 1, 2008 PAS, and determined that the Claimant required a Level of Care "B." This was derived from her assessment of 16 points for the Claimant, and resulted in the 93 monthly service hours noted in Exhibit D-3. Six points were awarded for medical conditions and symptoms, one for vacating, and nine for functional abilities in the home.
- 5) The Claimant's Case Manager testified that she believed the PAS was an accurate assessment of the Claimant.
- 6) The Claimant's Homemaker testified that he believed the Claimant might have misunderstood some of the questions from the WVMI RN on the day the PAS was completed, and answered incorrectly. He stated that when the Claimant lies in the bed, she has "sore points." Upon questioning for clarification, the WVMI RN testified that the condition described is not the same thing as *decubitus*, or open sores from pressure. Neither the Claimant nor her witnesses presented any other areas of dispute with the December 1, 2008 PAS.

### VIII. CONCLUSION OF LAW:

1) Policy dictates that an individual's Level of Care for the Aged and Disabled Waiver Program is determined by the number of points assessed on the PAS assessment tool. The Claimant received 16 points on her December 1, 2008 PAS, and was awarded a Level of Care 'B,' with a corresponding 93 monthly service hours. For the higher Level of Care, "C," the Claimant would require at least 18 points; however, there were clearly no areas of dispute that resulted in additional points. The Department was correct in its determination of Level of Care and corresponding service hours.

#### IX. DECISION:

It is the decision of the State Hearing Officer to **uphold** the Department's determination of homemaker hours under the Aged and Disabled Waiver Program.
