This change is being made to implement a waiver of the face-to-face interview at redetermination for 24 month Food Stamp AG's. These AG's are no longer required to complete a face-to-face interview at 24 months. The contact is accomplished using a mail-in form, the DFA-FS-24, generated by RAPIDS. August 2005 is the last month in which the 24-month redetermination will be accomplished by a face-to-face interview.

Also with this change, the OFS-FS-2 is no longer used as the 12-month contact for 24-month Food Stamp AG's. It will continue to be used as a change reporting form for all Food Stamp AG's. The 12-month contact for 24-month Food Stamp AG's is accomplished using form DFA-FS-12, which is generated by RAPIDS.

The Customer Service Reporting Center address will be listed as the address to which the client returns both of these completed forms.

Changes in Chapter 1 are:

Section 1.2: Information was added regarding initiating contact with law enforcement officials to disclose information about Food Stamp clients. This is based on a clarification from FNS.

Section 1.4,A: Form DFA-FS-12 was added.

Section 1.4,M: A reference to another section was added along with minor working changes.

Section 1.4,N: Information was added about forms DFA-FS-12 and DFA-FS-24.

Section 1.4,S: Exceptions to face-to-face redetermination interviews were added. Also, information was added to help clarify timeframes for the beginning date of eligibility, after a redetermination. Examples were also added.

Changes in Chapter 2 are:

Section 2.2,B: Information was added about the 24-month redetermination process. An ABAWD reporting requirement was added to this section. An item was also added to the list of "Considered Changes".

Section 2.2,C: Worker action regarding inactive and dormant EBT accounts has changed.
