RE: West Virginia Birth To Three Rate Adjustments

EFFECTIVE DATE: July 1, 2025

The West Virginia Department of Health, Bureau for Public Health, Office of Maternal, Child and Family Health, West Virginia Birth To Three (BTT) Program is pleased to announce an updated rate schedule for BTT services provided to eligible infants, toddlers, and their families/caregivers as a result of West Virginia Governor Patrick Morrisey's signing of the FY2026 Budget. This historic investment in BTT reflects the State's commitment to ensuring infants and toddlers who are at risk of or experiencing developmental delays receive the services needed for healthy growth and development.

The rate adjustments will be effective for dates of service beginning on and after July 1, 2025. Attached is a one-page rate table outlining the rate changes across disciplines. The rate adjustments for BTT providers in West Virginia align with current Medicaid rates paid to providers providing comparable services. The complete rate table with procedure codes will be published July 1, 2025 on the BTT website www.wvdhhr.org/birth23.

Many thanks to Governor Patrick Morrisey and the West Virginia State Legislature for recognizing the value in providing early intervention services to West Virginia's children. This investment will help support and maintain a robust network of comprehensive providers of BTT services. The BTT program remains committed to working with the West Virginia Governor's Early Intervention Interagency Coordinating Council and providers across the state to provide high quality early intervention services in the Mountain State.
