Attached is a copy of the findings of fact and conclusions of law on your hearing held June 18, 2003. Your hearing request was based on the Department of Health and Human Resources' action to, decrease the amount of your Food Stamps and, require a spenddown for the Medicaid Program..

In arriving at a decision, the State Hearing Officer is governed by the Public Welfare Laws of West Virginia and the rules and regulations established by the Department of Health and Human Resources. These same laws and regulations are used in all cases to assure that all persons are treated alike.

Eligibility and benefit levels for Food Stamps and SSI-Related Medicaid are determined based on current regulations. One of these regulations specifies that,

"Unearned income from Annuity Payments is counted for Food stamps and SSI-Related Medicaid." (West Virginia Income Maintenance Manual 10.3 J ANNUITY PAYMENTS).

The information submitted at the hearing revealed: You were given all disregards and deductions for the Food Stamp and Medicaid Programs.

It is the decision of the State Hearing Officer, to uphold the action of the Department to (1) Decrease the amount of the Food Stamps and; (2) Require a spenddown for Medicaid Benefits based on the income from the annuity payments.

#### VII. FINDINGS OF FACT

	wit. Bragg provided the following fricating outlinary.
	" case #4004938341 has requested a fair hearing based on the decrease in
her fo	ood stamps and the creation of a spenddown for her Medicaid case. The client was initially
appr	oved for foods stamps based on zero income that she had indicated at the interview.
Pend	ed client for a copy of her divorce decree and when it was received, it indicated that in the
divor	ce she receives the annuity from the death of her son and that she has life estate in the
form	er marital residence and that she is to make the mortgage payment of the home.

	Client's food stamps then decreased from \$141.00 monthly to \$96.00 monthly and giving od stamp case credit for the \$733.76 mortgage payment. The annuity if \$723.00. This has aused the Medicaid to have a spenddown of \$3,018.00 for a six month period."	
- Divorc	Ms disputed the testimony of Mr. Bragg. She did not provide a copy of the se Decree for review.	
-	The decision was given at the conclusion of the fair hearing.	
VIII.	CONCLUSIONS OF LAW	
-	West Virginia Income Maintenance Manual 10.3 J ANNUITY PAYMENTS states in part,	
	"Unearned income from Annuity Payments is counted for Food stamps and SSI-Related Medicaid."	
-	WVIMM Section 10.4 B INCOME DISREGARDS AND DEDUCTIONS states in part,	
"The following is the only allowable disregards and deductions for the Food Stamp Program: Earned Income Disregard; Standard Deduction; Dependent Care Deduction; Child Support Deduction; Homeless Shelter Standard Deduction; Medical Expenses and; Shelter/Utility Deduction."		
IX.	DECISION	
Ms did not provide any legal documents stating she did not receive a monthly annuity payment. Mr. Bragg gave Ms all allowable deductions and disregards for the Food Stamp Program. The unearned income from the annuity requires Ms to meet a spenddown to be eligible for SSI-Related Medicaid Benefits.		
	It is the decision of this State Hearing Officer, to uphold the action of the Department to (1) ase the amount of the Food Stamps and; (2) Require a spenddown for Medicaid Benefits on the income from the annuity payments.
